### **Corrales Animal Services Litter Permit Application**

This Litter Permit Application shall not be accepted unless accompanied by the permit fee, microchip number, and Intact Companion Animal Permit or application for Intact Companion Animal Permit, for the applicable intact dog or cat. A

**separate** application must be submitted for **each** dog/cat that has a litter. An owner who intentionally or unintentionally breeds a dog or cat and who does not have a current hobby breeder permit must purchase a litter permit for each litter.

No more than four Litter Permits per household in any consecutive 12-month period. A Litter Permit must be obtained prior to the birth of a litter or within one week after the birth of the litter. This permit expires six months from the effective date. Fees are non-refundable. Permits cannot be transferred.
